3. Target group

This instruction for use is intended for all users (doctors, dentists and professionals in charge of the processing of medical devices as well as hygiene professionals) in medical and dental facilities.

4. Intended purpose - intended use

Liquid concentrate free of aldehydes, phenols and QAC for the non protein fixing cleaning and disinfection of medical and dental instruments, rotating precision instruments and endoscopes.

Please note concerning disinfection:

- Wear protective gloves, an apron impermeable to water and protective glasses!
- Mark the tray with the date of preparation of the ready for use solution (for a longer period of use).
- Shelf life of the ready for use solution: unused = 30 days
- Durability in use: In principle, a durability in use of 7 days applies, if the solution is
 used exclusively for disinfecting previously cleaned instruments. If the solution is
 used for cleaning, it must be replaced every working day and/or if contamination
 is clearly visible.

5. Application



Disinfection – after pre-cleaning

5.1. Pour the concentrate into the tray (see table) and then fill with water (observe the exact dosage).

(e.g. $0.5 \% \triangleq 5 \text{ ml/}995 \text{ ml cold tap water} = 60 \text{ min}$

 $2 \% \triangleq 20 \text{ ml}/980 \text{ ml cold tap water} = 30 \text{ min.}$

- 5.2. Soak pre-cleaned instruments completely and bubble-free
- 5.3. Observe indicated contact time according to required efficacy (see table)

Further processing

- 5.4. Rinse the instruments with water (e. g. deionized, demineralized/drinking water). In case of persistent soiling pre-clean with plastic brush if necessary and repeat disinfection steps 5.2./5.3.
- 5.5. Dry on suitable nonwoven wipe or with suitable dry air
- 5.6. Check integrity
- 5.7. Depending on risk assessment continue processing of instruments (Follow standard operating procedure (SOP)) wrapped or unwrapped with appropriate thermal method (validated washer-disinfector/steam sterilizer)

7. Hazard statements and precautionary statements

Danger. Flammable liquid and vapour. Harmful if swallowed. Causes severe skin burns and eye damage. May cause damage to organs through prolonged or repeated exposure if swallowed. Very toxic to aquatic life. Toxic to aquatic life with long lasting effects. Contains Piperazine. May produce an allergic reaction.

Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Wear protective gloves/protective clothing/eye protection/face protection.

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting.

IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water [or shower].

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

Immediately call a **POISON CENTER/doctor.**

Do not mix with acids, products containing aldehydes or other cleaning agents and disinfectants!

8. Environmental and disposal instructions

The 0.5% ready-to-use solution is ecologically harmless.

Highly concentrated solutions can be disposed of in highly diluted form in the waste water. The unused product or product residues must be disposed of as hazardous waste in compliance with the Directive 2008/98/EC on waste as well as national and regional regulations. If possible leave the product in original container.

Do not mix with other waste materials. Packaging contaminated with the product is considered as hazardous waste and must be disposed of accordingly.

The surfactants contained are biodegradable according to OECD.
